School Description and Mission Statement (School Year 2007-08)

This section provides information about the school, its programs and its goals.

Morning Creek is an exemplary Blue Ribbon and 2006 California Distinguished School. Our school offers high quality learning experiences in a very supportive and nurturing atmosphere. Teachers and support staff are committed to educational excellence and work together in a cooperative, supportive, and professional manner. Our teachers work as a professional learning community to review student assessments, plan standards-based learning opportunities and monitor student progress throughout the year. Each Thursday afternoon students are dismissed early which allows teachers time to work in their grade level teams. By working in a team, teachers are able to leverage the professional intellect of their colleagues to better support all students learning.

Morning Creek is located 20 miles north of downtown San Diego in the community of Sabre Springs. Our school was built in 1990 and is 18 years old. Currently, we have 666 students on our campus. Our student body consists of students from richly diverse cultural, ethnic, linguistic, and religious backgrounds. Our student demographics are 41% Caucasian, 24% Asian, 12% Hispanic, 11% Filipino, 4% African American and 9% other ethnicities.

Morning Creek has experienced changes in enrollment over the years. At one time Morning Creek had over 1,000 students in attendance but new schools built in the area helped reduce enrollment. However, in the past three years, Morning Creek has grown from 519 students to 666 students. In addition to increasing enrollment, we have also transitioned from half-day kindergarten to a full-day kindergarten program during the 2008-09 school year. Our English learner program has also increased dramatically this year, growing from 75 students to 160 students. All of our teachers hold specialized credentials for working with English learners.

Based upon community need, parent-paid child care is provided before school, beginning at 6:30 a.m. and continues until 6:00 p.m. through the PUSD Extended Student Services (ESS). The program operates during vacations and on non-school days, provides a

bridge between home and school. The 165 students participating complete their homework in a supervised environment, eat healthy after school snacks, have access to computers and participate in a wide variety of learning games and activities.

In order to prepare students for a successful school experience, a parent participation Preschool is operated on our site. The program is designed for three and four year olds who attend half-day sessions either 2 or 3 days a week.

We have a very active PTA and Foundation on our site. Our PTA and Foundation are instrumental in providing funding for a number of programs on our site. This past year our Foundation sponsored a "Country Affair" fundraising event which garnered over \$30,000 for our school. Our PTA and Foundation work separately but are aligned in supporting our school goals. Reading Plus, a PE Instructional Aide, counseling time, instructional supplies and field trips are supported through their efforts. Our volunteer program is strong and is continually encouraged by staff. Volunteers can be seen on campus all throughout the day, everyday!

Morning Creek is truly a remarkable school which is built on a strong tradition of excellence. Every year we continually look at ways to create an atmosphere where all students can learn and thrive. We wholeheartedly support our district's motto – "All Students Learning – Whatever it Takes."

Morning Creek staff and parents feel that our collaborative spirit is our greatest strength. We all work together to create a school environment which is stimulating and student-centered! As our district mission states, "We are committed to Excellence in All We Do."

IV. School Facilities

School Facility Conditions and Planned Improvement (School Year 2008-09)

This section provides information about the condition of the school's grounds, buildings, and restrooms based on the most recent data available, and a description of any planned or recently completed facility improvements.

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology.

In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

Three district wide professional growth days are provided which creates time for district wide and site selected activities for professional growth. Poway Professional Assistance Program provides support for new teachers. Teachers are supported with stipends to participate in the National Board Certification process.
