School Description and Mission Statement (School Year 2008-09)

This section provides information about the school, its programs and its goals.

Sunset Hills Elementary School, established in 1974, is located in the San Diego community of Rancho Penasquitos, situated 20 miles north of downtown San Diego in the award-winning Poway Unified School District. Our community has a rich diversity of cultural, ethnic, linguistic and religious backgrounds. Approximately forty-seven percent (47%) of our 643 students are non-Anglo, with the largest racial group being Asian. Approximately ninety students are currently receiving direct services or are being monitored through our ELL program. There are thirty (30) primary languages represented at our school.

Sunset Hills has a long-standing reputation of providing an excellent learning environment. Visitors regularly comment about the friendly and welcoming environment of our school and the intense level of commitment every staff member has for each student's success. Our slogan is "Educating for Life". We continue to provide differentiated instruction in order to make this goal a reality. Our focus is on the achievement of grade-level standards for all students, and we have instituted a variety of support systems for students who need the extra help to do so.

Professional growth is a fundamental characteristic of the Sunset Hill's staff. We willingly share our expertise with each other. Many of our teachers have taken advantage of the District Teacher Learning Cooperative (TLC) as a means to grow professionally.

We have a dedicated, student-focused PTA, which provides support for learning at our school. Funds raised by PTA support visual and performing arts, art mentors, technology, and an array of auxiliary activities. Actively involved parents are members of the Sunset Hills Foundation, which raises funds to support student learning as well. The Foundation has raised tens of thousands of dollars each year to fund instructional supplies, personnel, and computers.

We have the benefit of operating in a community that expects academic excellence and we have benefitted from parental collaboration. We intend to maintain our professional learning community through collaborative dialogue and student success.

III. School Climate

School Safety Plan (School Year 2008-09)

Sunset Hills places strong emphasis on safety for students and staff. Emergency plans are reviewed frequently. Annual training procedures and drills for earthquakes, lockdowns, and fire and bus evacuation are held. The district maintains a collaborative relationship with local law enforcement and the Office of Emergency Services to ensure optimal preparedness. Maintenance staff work with a scheduled preventive program to offset costly repairs at our older sites, whenever possible. The school has an up to date Asbestos Plan. Extended Student Services is available to students for before and after school childcare.

IV. School Facilities

School Facility Conditions and Planned Improvements (School Year 2009-10)

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology.

In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA for grades three through eight and science in grades five and eight and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Research supports the positive effects staff development has on increasing student learning. A wide variety of professional development opportunities are available to teachers and staff including utilization of effective instructional strategies, computer technology, mathematics and writing seminars, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional growth activities at the school, district, state, and national level. (Additionally schools may utilize minimum days created by "Time Banking" to provide weekly periods for staff collaboration and professional growth). Three district wide professional growth days are provided which creates time for district wide and site selected activities for professional growth. Poway Professional Assistance Program provides support for new teachers. Teachers are supported with stipends to participate in the National Board Certification process.

XII. National Assessment of Educational Progress

National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities and English language learners is reported based on three levels (identified, excluded, and assessed). Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks.
