School Description and Mission Statement (School Year 2007-08)

This section provides information about the school, its programs and its goals.

Painted Rock Elementary School, located in the heart of the Green Valley community of Poway first opened to students in 1972. As an elementary school in the Poway Unified School District, it is committed to the District Core Values and Mission Statement.

In 2005-2006, Painted Rock served 644 students in a comprehensive kindergarten through fifth grade program, including special education. Student attendance is very good at Painted Rock with an average daily absence rate less than two percent. The socioeconomic make up of the community is 60% professional, 35% semi-professional, and 5% unskilled workers. The ethnic make up of the student population is 6% Hispanic, 6% Pacific Asian, 2% African American, 5% other and 79% Anglo. There are currently 18 students classified as limited or non English speaking. Currently, 4.71% of the student population are on a free or reduced lunch plan. The transiency rate is very low with less than 2% of the student population withdrawing or moving during the school year.

Class size reduction (CSR) was implemented in grades K-3 during 1997-1998, resulting in a 20:1 student/teacher ratio. Kindergarten classes have utilized the partnership model, helping to reduce class size to 10:1 during half of the kindergarten day.

Teachers participated in reading, language, and math trainings that enabled them to implement new curriculum and provide more effective instruction in the CSR classrooms. District designed assessments were administered to determine the effectiveness of class size reduction and teachers participated in district training for accurate scoring. The testing provided authentic measures of student performance and data was used to help guide instruction in CSR classrooms.

During the 2005-2006 school year, 50 students were enrolled in the GATE Program. The Resource Specialist Program served 28 students and the speech/language specialist served 56 students. Painted Rock houses the only class in the Poway Unified School 2007-08 School Accountability Report Card

District serving Emotionally Disturbed (ED) students with 9 students enrolled in that class. Over 250 students have participated in the Dragon Reading Club, a peer-tutoring program that is coordinated by the Principal. There are currently 125 students in our Extended Student Services Program.

The 2005-2006 staff included 31 full-time credentialed teachers. In addition, parent volunteers coordinated a reading program (SOAR), a cross-age tutoring program (Dragon Club), as well as OASIS, an intergenerational tutoring program. A reading aide provided additional group work to boost the reading achievement of selected first and second graders. Support staff included a speech/language specialist, resource specialist, special day class teacher, psychologist, counselor, and an orchestra/band teacher. A librarian coordinated library schedules, provided instruction on library skills, and monitored textbook and audio-visual equipment circulation. Instructional aides provided needed instructional services for physical education programs, English Language Learners, and music. We provided a Student Services Specialist who taught whole class and small group lessons in problem solving, anger management, impulse control, bullying prevention and cultural diversity. Other support staff included an administrative assistant, health aide, custodian, and recess/noon-duty supervisors. Office staff and classroom teachers coordinated volunteer efforts along with the PTA, resulting in 80-90 volunteers each day.

IV. School Facilities

School Facility Conditions and Planned Improvement (School Year 2008-09)

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology.

In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

Research supports the positive effects staff development has on increasing student learning. A wide variety of professional development opportunities are available to teachers and staff including utilization of effective instructional strategies, computer technology, mathematics and writing seminars, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional growth activities at the school, district, state, and national level. (Additionally schools may utilize minimum days created by "Time Banking" to provide weekly periods for staff collaboration and professional growth). Three district wide professional growth days are provided which creates time for district wide and site selected activities for professional growth. Poway Professional Assistance Program provides support for new teachers. Teachers are supported with stipends to participate in the National Board Certification process.
