Dear Parents:

The federal government reimburses qualified school districts for the impact on those school districts from federally owned property and federal employment. Federal law requires all school districts that are eligible to receive reimbursement from the federal government to report the number of students who live on federal property, students whose parents/guardians are employed on federal property, or students whose parents/guardians are associated with the federal government (such as being on active military duty).

To obtain these additional federal funds for our district, the federal government requires an annual survey of all students; this survey form is attached. The information gathered from this survey is summarized in a report that identifies only the total number of qualified students. Our response to the federal government does not include any names, addresses, places of employment, etc. Only total numbers are forwarded. All survey forms are stored in our central offices and not released to any other agencies or individuals.

We would appreciate your assistance in completing the survey form and returning it to your child's school by the appropriate deadline date. The completion of this form allows our district to obtain these additional revenues, which, if not applied for, will be assigned to other school districts throughout the nation. Please assist us in obtaining these additional revenues so that we can provide a higher quality education for your child.
