#### B. REPORTS / PRESENTATIONS

## **B-1** Student Board Representative Reports

Student Board representatives Brooke Stark from Poway High School, Andrea Brown from Abraxas High School, Karen Mejia and Tim Kim from Rancho Bernardo High School, Alanah Grisham from Mt. Carmel High School, and Nicole Rosario from Westview High School reported on events and activities at their respective schools. The Student Board representative from Del Norte High School was not present. President Ranftle and Dr. Collins presented a Certificate of Appreciation to Karen Mejia for her service as School Board Representative during 2010. Certificates for Meghan Spooner and Abbey Cavendish will be given to them at their school sites.

## **B-2** (a) Superintendent's Briefing

The following updates on current issues and events were presented:

- Dr. Collins mentioned that the Consent Calendar contained the promotion of Todd Cassen from Area Principal to Principal of Westview High School and introduced Mr. Cassen. Dawn Kastner was transferred from Westview to Mt. Carmel High School to replace Tom McCoy.
- Dr. Collins highlighted various achievements and honors listed in subsequent agenda items
- Governor Brown released his proposed 2011-2012 state budget on January 10, and is proposing no further cuts to education. The Governor acknowledged that public education

has taken a disproportional amount of state budget cuts since 2008. An unknown factor is that, although he says there will be no cuts to education, his proposal for 2011-2012 includes an increase in the deficit factor that would reduce funding by approximately \$19 per student. For our district, this proposed reduction would be approximately \$650,000. The Governor's proposal also assumes that the legislature will put a measure on the June ballot to extend the state sales tax, personal income tax, and vehicle tax for an additional five years. It further assumes that voters will approve this measure. If the ballot measure does not pass, it is estimated that the state budget will have a \$9 billion problem and that \$2.3 billion will come from K-12 public education, which would be about \$11.5 million for PUSD (or a loss of \$330 per student). Dr. Collins said the legislature must vote by March to place the measure on the June ballot, and if it is placed on the ballot, education funding will not be known until after the June election. It is important that PUSD maintain its reserves because of an anticipated deficit of \$16 million for 2012-2013.

## (b) Student Recognition

Dr. Collins commended the 63 students who achieved the maximum possible score of 800 in subject areas on the October 2010 Scholastic Aptitude Test (SAT). President Ranftle and Dr. Collins presented Certificates of Achievement to five students who earned the highest score of 2400 on the national SAT. He also introduced Jason Noles, who has signed on as a cartoonist with *Poway Patch*.

## (c) Staff Recognition

Dr. Collins recognized Noreen Walton for being appointed to a six-year term on the California Postsecondary Education Commission by former Governor Schwarzenegger, and Mike Tarantino for being elected to the National Board of the Sports Turf Managers Association representing K-12 schools.

## (d) District Recognition

Dr. Collins acknowledged Abraxas High School for being selected as a 2011 California Model Continuation High School by the California Department of Education, which is the third time Abraxas has been a Model Continuation High School. Bernardo Heights Middle School library was chosen for national recognition as an exemplary school library by the American Association of School Librarians.

## **B-3** Board Member Reports

Board members reported on their activities and events attended in the previous month.

## C. PUBLIC COMMENTS

Beverly Thomas shared her concern about her son continuing to receive needed services while attending New Directions. The Board directed Ms. Thomas to work with Dr. Mel Robertson on this issue.

Susan Chu expressed her misgivings about the placement of senior pictures within the Westview yearbook. The Board directed Dr. Mel Robertson to work with Ms. Chu on this issue.

It was moved by Mr. Gutschow, seconded by Mrs. Vanderveen, that, based upon the Board's review of the Findings of Fact and Recommendations submitted by the administrative hearing panel, the action of the recommendations presented regarding Case Nos. 2010-2011.12, 2010-2011.18, 2010-2011.22 and 2010-2011.24 be ratified. *Motion carried unanimously*, 5-0.

## **D-102** Ratification of Stipulated Agreements for Student Expulsions

It was moved by Mrs. Vanderveen, seconded by Mr. Davis, that the Board of Education approve and ratify the stipulated agreements for expulsion in Case Nos. 2010-2011.25 and 2010-2011.27. *Motion carried unanimously*, *5-0*.

## **D-103** Readmission of Students on Expulsion

It was moved by Mr. Patapow, seconded by Mr. Gutschow, that students represented by Case Nos. 2009-2010.47, 2009-2010.49, 2009-2010.53, 2009-2010.56, 2009-2010.58, 2009-2010.65, and 2009-2010.84 be readmitted to the Poway Unified School District. *Motion carried unanimously, 5-0.* 

# D-104 Public Hearing and Approval of General Waiver Request to Extend for Sixty Days the February 1 Deadline for Posting School Accountability Report Cards

President Ranftle opened a public hearing at 6:53 p.m. to receive public comment. Hearing none, the public hearing was closed. It was moved by Mrs. Vanderveen, seconded by Mr. Gutschow, that the Board approve a general waiver requesting an extension of the February 1, 2011, deadline to post School Accountability Report Cards online. *Motion carried unanimously*, 5-0.
