Audition Information

What to wear: Black bootie shorts and a black form fitted top. Hair secured and out of face. Bring jazz shoes or appropriate dance shoes. Socks will not be permitted. Bring water!

Workshops: During workshops, we will teach material that will be judged on the day of the audition. This includes: Across the floor combinations, 1 sideline filler, and 1 jazz dance. Participants should wear appropriate dance attire that allows for proper movement and ability. Jazz shoes or appropriate dance shoes are required. Socks will not be permitted. Bring water!

The following criteria will be used to judge the audition:

- Appearance/Personality
- Overall crowd appeal
- Strength of performance
- Sideline Filler Routine
- Choreographed Jazz Dance
- Memorization of material
- Technique
 - Triple pirouettes (more preferred)
 - A la seconds
 - Various leaps
 - Leg hold turns
 - Flexibility
