2022-23 School Overview

PPMC was established in the Fall of 2022-2023 and is located on the Palomar Community college Education Center Campus in Rancho Bernardo. This Middle College format follows the basic format used throughout the nation as it utilizes a Community College for students in a dual enrollment (high school/college courses). As each region of the nation has different needs, PPMC is thrilled to meet at the Palomar Community College facility instead of using a high school base as some programs must do.

PPMC remains relatively small as it opened with 37 11th graders. The focus remains on assisting underrepresented students who have not previously thrived academically, or who have faced emotional difficulties while enrolled in comprehensive schools with 1,000-3,000 students in attendance. The student population of PPMC provides for meeting the diversity of student ethnicity and/or culture, and it incorporates a more personalized involvement of both parents and students. The construct of PPMC allows for students who want to focus on dual enrollment while attending school on a smaller campus holding far fewer students.

School Facility Conditions and Planned Improvements

Poway to Palomar Middle College is located on the campus of Palomar Community College's Rancho Bernardo Education Center. The building is newly constructed and has minimal use due to COVID 19. Crucial to the successful education of our students is a healthy learning environment that includes structurally safe facilities and grounds that satisfactorily comply with environmental standards and conditions. Schools that maintain a clean and orderly environment experience the many benefits that come from pride and ownership among students, faculty and the support of the community.

Palomar College's Preventive Maintenance is a high priority service in their approach to comprehensive maintenance programs. PM is an effective method of avoiding potential failure of facilities equipment and systems. Through an inventory and scheduling system, work crews are assigned to perform inspections, adjustments, cleaning and routine service on virtually all facility related major equipment and systems.

The goal of preventive maintenance, as a component of a facilities maintenance system, is to maximize the useful life of all building and grounds systems. The requirement for preventive maintenance versus breakdown maintenance was recognized by the Facilities Department many years ago. In 1980, the department took a positive step in setting up a program that would benefit all Facilities staff. Working hours were rescheduled so work could be completed in classrooms without interrupting instruction.

Preventive maintenance is scheduled on two buildings a week; this schedule allows the staff to completely check every room in every building at least twice per year.

Campus employees are encouraged to report any deficiencies as they occur.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

2022-23 Opportunities for Parental Involvement

Though the school is operating in its first year and remains relatively small, PPMC places a premium on welcoming and involving parents to better meet the needs of students. This year, the Parent Volunteer Committee was established as the embryonic version of a PTSA or Foundation format utilized at the comprehensive schools. The Parent Volunteer Committee acts as the bridge between families and staff as parent monthly meetings are scheduled and attended. Discussion points focus on school budget, fundraising, and family and student needs. Additionally, a parent Facebook page continues to be formatted as the most comprehensive means of inviting more parents, outside of attending the monthly parent meetings, to provide input and feedback.

Currently, to meet the financial costs for having a student Homecoming Dance, parents and PPMC staff worked together to advertise for a Board and Brew family night as the means to augment the cost not covered by the \$20 student charge. Dances provide students and guests the opportunity for social interaction with a Spring Dance scheduled in the Spring. Though PPMC did not earn a profit margin during the last fundraiser, parents helped insure all costs for the Homecoming Dance were met. As the district provides food for schools, currently no specific family/student needs outside of the academic day have been reported as yet. School counselor, Tony Sims, schedules quarterly meetings with students and families to review progress toward graduation and class selection for upcoming semesters.

Lastly, parents are invited to participate as guest speakers and club supervisors. Under the supervision of a parent volunteer, our Cyber Patriot club/team came in second place in their first virtual competition.

The Daily Crime Log will include the most recent information from the past 60-day period. Any portion of the log that is older than 60 days is available within two business days of a request for public inspection. A weekly, electronic version of the log may be found on Palomar's website. It is posted on each Friday for convenience purposes only and the most up to date version is available at the Public Safety Offices of each campus. The Palomar Public Safety office is located on the second floor (on the south side of the building). The hours of operation is 8:00am to 5:00pm, Monday through Friday. In addition, a team of Campus and Parking Services specialists provides services such as safety escorts, vehicle battery jumps, lost and found, room unlocks, and parking enforcement. Safety drills for lock downs, earthquakes and evacuations are scheduled in the fall and the spring quarters. The building is equipped with electronic door monitoring and can be locked down at the press of a button. The safety plan was discussed with students and staff on August 15, 2022 and will be review by the PUSD school board on January 12, 2023.
