

TPMS After-School Education and Safety-ASES

Welcome to the After School Education and Safety (ASES) Program! ASES is aligned with the regular school day and provides a safe physical and social-emotional environment that supports building positive relationships. The program is **free of charge**, funded by a state grant, and has attendance requirements for all participating students. ASES is offered before and after school every day that school is in session.

Attention Parents: *Both the Before-School and After-School Programs are currently full. Waiting list applications are being accepted for students who commit to attend 4 days per week for the morning program and 5 days a week for the afternoon program, respectively.*

Important Information

Before-School Program:

Our Before-School Program is located in the TPMS MPR (Gym). Program hours are Mon-Fri 6:30am-8:25am. Students are expected to check-in before 7:29 am to meet attendance requirements. After 7:29am, the state records a student as late and attendance does not count for the day.

After-School Program:

After School Program hour are 3:15pm-6:15pm. To meet attendance requirements students must stay signed in until 4:45 each day. Sign-out for the After-School Program is in the front of the school, in room 102.

Location and times:

Numerous classrooms and other rooms are used for our programs as there are many different activities used in the program.

ASES Clubs and Activities:

Our activities calendar for our after-school program changes every 6 weeks. We offer a wide variety of extracurricular activities for all students. We also offer district wide culminating events throughout the year. Program activities may include:

After School Sports:

All after school sports are sponsored and coordinated through the After School Program. Students must sign up through the After School Program but do not need to be enrolled in the Program.

Program requirements:

The State of California and the San Diego County of Education have tightened the attendance requirements for all before and after-school programs that are funded through the After-School Education and Safety (ASES) initiative. Since these programs are free of charge we must follow these requirements in order to continue providing programming for our students. We are required to use an automated sign-in/sign-out system which will report attendance directly to SDCOE. Unfortunately students will be dropped from the program if they do not meet the attendance requirements.

Attendance Requirements are:

Before-School Program:

A minimum of 4 days/week (with student arriving by 7:29 am). Priority is given to students attending 5 days a week.

After-School Program:

Students must attend five days a week. Students must stay until at least 4:45 p.m. We do not accommodate students on a “drop-in” basis.
