



**POWAY UNIFIED SCHOOL DISTRICT PARENT/GUARDIAN  
HEALTH AND SAFETY AGREEMENT FOR HIGH SCHOOL IN-PERSON INSTRUCTION AND  
ATHLETICS/EXTRACURRICULAR ACTIVITIES FOR THE 2020-2021 SCHOOL YEAR**

I have read, understand, and agree to the following terms and conditions:

**COVID-19 Plan:** Parent/Guardian acknowledges that he/she has received and reviewed the District's Guidebook which is available online at:

Parent/Guardian agrees to review the District's COVID-19 Prevention plan with their student(s) RE:

- a. Face Coverings
- b. Physical Distancing
- c. Arrival/Dismissal
- d. Lunch/Breaks
- e. Healthy Hygiene

To prevent the spread of COVID-19, the District will also review these rules and protocols with students throughout the school year.

**Daily Home Health Screening of Student(s):** Parent/Guardian agrees to screen his/her student(s) for COVID-19 before school each day or before taking them to a school activity such as but not limited to practices, competitions, meetings, or rehearsals. Specifically, Parent/Guardian agrees to do all the following prior to bringing their student(s) to campus or school related activities:

1. Parent/Guardian shall screen student(s) for any of the following symptoms associated with COVID-19: cough, shortness of breath or difficulty breathing, chills, fatigue, muscle or body aches, headache, new loss of taste or smell, sore throat, nasal congestion or runny nose, nausea, vomiting, diarrhea, or loss of appetite. Parent/Guardian agrees if their student(s) present with any of these symptoms, Parent/Guardian will not send/bring their student(s) to the school or any school activities.
2. Parent/Guardian agrees if student(s) has a fever of more than 100 degrees, Parent/Guardian will not send student(s) to school or any school activity. Parent/Guardian further understands and agrees his/her student(s) will not be sent to school or any school activity if student(s) has been administered medication for the purpose of reducing a fever within the last 24 hours.
3. In the event a student(s) has been exposed to anyone who has tested positive or are presumed positive for COVID-19 in the last two weeks, Parent/Guardian will not send the student(s) to school or any school activity. Parent/Guardian shall notify the District that the student has been kept home for this reason. Parent/Guardian understands that his/her student(s) will not be able to return to school or school activities until permitted by the District in compliance with direction from the San Diego Health & Human Services Agency and the San Diego Public Health Order.

**Health Screenings at School:** Parent/Guardian understands and agrees that all students shall undergo the following District administered health screening upon arrival at school each day and potentially at other times during the school day as necessary to prevent the spread of COVID-19:

1. Student(s) temperature will be taken using a touchless thermometer upon entering the school or before getting on the bus.
2. Student(s) will be monitored throughout the day for signs or symptoms of COVID-19.
3. Student(s) exhibiting symptoms of illness throughout the day will be required to go home.

**Face Coverings:** Parent/Guardian understands and agrees that unless exempt, students in grades Preschool – 12 must wear face coverings. Parent/Guardian understands and agrees that his/her student(s) may be excluded from school or school related activities if they refuse to wear a face covering consistent with the rules set forth in the District's COVID-19 Prevention Plan.

**Exhibiting Symptoms at School:** Parent/Guardian understands and agrees that if his/her student(s) exhibits COVID-19 symptoms during the school day or during school activities, Parent/Guardian will pick up his/her student(s) as soon as reasonably possible but no later than within one hour after being notified by the school. When Parent/Guardian arrives at the school, Parent/Guardian will call the school office and remain in his/her vehicle.

**Disclosure to Help Prevent Community Spread of COVID-19:** Parent/Guardian understands and agrees that if his/her student(s) tests positive for COVID-19 or if the District otherwise reasonably suspects his/her student is infected with COVID-19, the District is required to notify the San Diego Health & Human Services Agency. Additionally:

1. In order to conduct contact tracing, the District may be required to contact the student's close contacts at school who may have been exposed to the virus. To protect student privacy, the District will only inform close contacts that they may have been exposed to someone with the infection. The District will not disclose the identity of the student(s) who may have exposed them.
2. To help protect against community spread, the District will be performing its own contact tracing. Parent/Guardian agrees for the District to ask his/her student(s) and Parent/Guardian questions about everyone within the school community whose student(s) may have had close contact with during the timeframe they may have been infectious.

**Nondiscrimination:** The District prohibits discrimination against any student(s) who has been diagnosed with COVID-19, whose family member has been diagnosed with COVID-19, or who is perceived to be a COVID-19 risk. If you feel your student is being discriminated against as a result of COVID-19, please notify the District immediately.

**Responsibility to Quarantine:** Parent/Guardian understands the District may direct his/her student(s) to quarantine either because they are suspected of having COVID-19 or because his/her student(s) has been in close contact with someone suspected of having COVID-19. If directed to quarantine, Parent/Guardian understands and agrees to the following:

1. Students who are required to quarantine but feel well enough to attend school or participate in school activities will be expected to avoid coming to school or participating in any school activities while quarantining including but not limited to practice, competition, or rehearsal for the entire period of quarantine.
2. Students who are required to quarantine may not return to in-person instruction or any school related activity until permitted to do so by the District in compliance with direction from the San Diego Health & Human Services Agency and the San Diego Public Health Order.
3. If an entire cohort (which can include a class, group, or team) is quarantined, remote learning will be provided through virtual synchronous and asynchronous methodologies.

**Visitors:** Parent/Guardian understands that due to the current public health guidelines, non-essential visitors will not be permitted to be on campus during the school day. Only staff, students and essential visitors may access campus. Spectators for school activities may be limited and allowed on a case by case basis following the CDPH Guidelines.

**Recommended At-Home Cleaning Procedures:** To help reduce the spread of COVID-19, the District encourages Parent/Guardian to frequently wash their student's commonly touched items such as backpacks, lunch boxes, supplies, water bottles, clothes, and equipment. Cloth face coverings should be washed daily.

**Athletic/Extracurricular Activities:** Parents/Guardians understand athletic/extracurricular activities are optional and student participation is voluntary. Athletic activities include but are not limited to conditioning, practice, training, and competition when permitted. Extracurricular activities include but are not limited to club meetings, performing arts rehearsals, ASB activities, and competitions when permitted. In consideration for allowing student participation in voluntary Athletics Activities, this document acts as the Informed Consent document required by the California Interscholastic Federation (CIF). The above outlined guidelines are to be adhered to by coaches, advisors, students, and parents/spectators while on campus, at school events, home or away competitions, or anytime the team/cohorts are together.

**COVID-19 Return to Play Protocols:** Parents/Guardians acknowledge and understand by allowing their student(s) to participate in Athletic Activities, there is an increased risk of their student(s) being exposed to and possibly contracting COVID-19. Student-Athletes who test positive for COVID-19, or are presumed positive for COVID-19, will be required to be cleared by a physician to return to practice and will follow the Graduated Return to Play Protocols outlined by the California Interscholastic Federation.
